

**INSTRUCTIONS: READ THIS BEFORE CONTINUING**

1. Please print legibly and in pen.
2. Complete all fields as applicable to your application.
3. All applicants must fill out Part 1.
4. Gate Key Card issuance requires a valid Restricted or Non-restricted Airside Area Pass.
5. Applications for an Airport Vehicle Operators Permit require a valid Pass, Driver's License, and may require a Radio License and AVOP testing.
6. All vehicles must have registration and insurance documents available when airside; these documents must be presented upon request from RCMP or Red Deer Regional Airport staff.

The Red Deer Regional Airport respects your privacy. The information that you provide us in the Red Deer Regional Airport Consolidated Security Application Form will be used by the airport to assess possible security access.

The Red Deer Regional Airport will not use or disclose personal information for any purpose other than those for which it was collected, except as required by law, or with consent.

Personal information is retained only as long as necessary for the fulfillment of the purposes for which it was collected, or as required by law.

**Restricted Area Pass Objectives and Terms of Issue**

The aim of the Red Deer Regional Airport Restricted Area Pass is the prevention of unlawful acts of interference with civil aviation by the granting of clearances to persons with a need and right to access the Airport. Anyone who requires a Restricted Area Pass shall either call the Red Deer Regional Airport Administration Office at 403-886-4388, submit a request on the website (<https://www.flyreddeer.com>), or email [info@flyreddeer.com](mailto:info@flyreddeer.com), and make an appointment.

Applicants must apply in person with Valid Government Identification. A Pass will only be issued if the application has been endorsed in writing, by the Authorized Signing Authority of the Company or Hangar owner.

**OBJECTIVE**

The objective of the Red Deer Regional Airport Restricted Area Pass is to prevent the uncontrolled entry into a restricted area of the airport by any individual who:

- I. is known or suspected to be involved in activities directed toward or in support of the threat or use of acts of serious violence against persons or property;
- II. is known or suspected to be a member of an organization which is known or suspected to be involved in activities directed toward or in support of the threat or use of acts of serious violence against people or property;
- III. is suspected of being closely associated with an individual who is known or suspected of:
  - being involved in activities referred to in (I.);
  - being a member of an organization referred to in (II.); or

- being a member of an organization referred to in (V.) hereunder.
- IV. the Red Deer Regional Airport reasonably believes, on a balance of probabilities, may be prone or induced to:
- commit an act that may unlawfully interfere with civil aviation; or
  - assist or abet any person to commit an act that may unlawfully interfere with civil aviation.
- V. is known or suspected to be or to have been a member of or a participant in activities of criminal organizations as defined in Sections 467.1 and 467.11 (1) of the Criminal Code of Canada;
- VI. is a member of a terrorist group as defined in Section 83.01 (1)(a) of the Criminal code of Canada.

Any person matching the individuals listed above may be excluded from consideration for the issue of a restricted area pass.

### TERMS OF ISSUE

As an applicant for, or a holder of, the Red Deer Regional Airport Restricted Area Pass I understand, agree to, and will abide by the following terms of issue.

- 1) That I will disclose any personal involvement in current or past activities that may exclude me from consideration for the issue of a Restricted Area Pass (RAP);
- 2) That the Pass issued to me is the property of the Red Deer Regional Airport;
- 3) That I will safeguard the Pass at all times and report loss or theft of the Pass without delay to the Signing Authority Officer in my organization and to the Red Deer Regional Airport Administration Office;
- 4) **That I will not be issued a replacement RAP or access card for one that has been lost or stolen until payment of a \$20.00 administration fee (each) has been received by the Red Deer Regional Airport Administration Office.**
- 5) That I will not permit unauthorized use of the Pass and will wear/display the Pass at all times when I am in the airport restricted area, on my outermost garment at or about chest level in a manner that is easily visible;
- 6) That I will not enter or remain on Red Deer Regional Airport restricted area without my Pass in my possession and visibly displayed;
- 7) That I will not knowingly and willingly assist any person not in possession of a valid Pass to gain entrance into a restricted area;
- 8) That I will surrender the Restricted Area Pass on termination of employment/need to access, or on demand of the Red Deer Regional Airport;
- 9) That my employer will notify and surrender the Pass upon termination of employment. My employer will notify the Red Deer Regional Airport Administration Office in writing of any person who no longer requires their Pass;
- 10) That I will surrender the Red Deer Regional Airport Restricted Area Pass upon the expiry date to the Red Deer Regional Airport at which time I can apply for a new Pass;
- 11) That where there is a change in submitted information or change in access level status, the Red Deer Regional Airport will be notified and the Pass returned for review and revalidation;
- 12) That I agree to abide with every lawful directive given by an authorized person, while on the property of the Red Deer Regional Airport.
